ABTRACT SUBMISSION GUIDELINES

- Each participant may submit only one (1)
 abstract as presenter but can be a co-author of
 other abstracts. The first author must be the
 presenting author.
- 2. The work may be of research (qualitative or quantitative), case report, case series, concept paper or systematic review.
- 3. Submit the soft copy of the Abstract by 10th October 2021.
- 4. The presenter should submit an online copy of the abstract in word document soft copy using the template provided in MACT website (https://mact.org.my/).
- Times New Roman font (size 12) with a total word count of 300 words excluding the title, authors, affiliations and keywords.
- 6. The title of the project should be in **bold**.
- 7. List each author's name with the surname (Last name) followed by first and middle initials. Eg. Ali M.M. or Lee E.H. or Murali M.R.
- 8. Include the affiliated department of the authors.
- 9. The conflict of interest (COI) of each author must be clearly stated.

1. Abstract submission deadline: 10th October 2021

Abstract Content

Background:

Two to three sentences of the research background.

Objectives:

Statement of objective(s) of the study. Eq. *To determine*

Methods:

If the study involved clinical human study or pre-clinical animal study, the research ethics approval number shall be stated. Include a brief description of the study design/methods used.

Results:

All methods stated shall have their respective results, where the appropriate statistical significance should be stated. Do NOT include any figure or table. The entire abstract shall not exceed one A4 page or a maximum of 400 words (including background, objectives, methods, results, discussions, conclusions and clinical applications).

Discussion:

Statement of discussion(s).

Conclusions:

A statement that summarizes your conclusion.

Clinical Implications:

What are the clinical implications of this study?

Keywords:

Type five keywords related to your research here; each separated by a comma (,).

Conflict of Interest (COI):

Clearly state the conflict of interest here. If no potential COI exists, state "The authors declare that there is no conflict of interest."

Acknowledgements:

Include statement(s) of acknowledgement here (if any).
